B.2 <u>CONTRACT TYPE</u>

The District contemplates award of a Requirements Contract with a fixed price component.

B.3 <u>DESIGNATION OF SOLICITATION FOR THE DISTRICT OF COLUMBIA</u> <u>SUPPLY SCHEDULE (DCSS)</u>
