1. <u>AUTHORIZATION:</u>

2. <u>MINIMUM REQUIREMENTS:</u>

The District of Columbia Office of the Chief Financial Officer, Office of Contracts, on behalf of the Office of Finance and Treasury (OFT) (the "District"), has a requirement for Bloomberg Professional Subscription Services (BPSS) for the District of Columbia's Other Post-Employment Benefits Fund (OPEB Fund). OPEB requires BPSS to assist in the management of retirement asset for each respective plan in which fiduciary oversight has been delegated.

3. <u>ESTIMATED REASONABLE PRICE AND REASONABLENESS</u> <u>DETERMINATION:</u>

The estimated contract total price is not to exceed \$130,470.00.
