## 1. <u>AUTHORIZATION</u>

D.C. Municipal Regulations Title 27 §3307 and PPRA §419

#### 2. MINIMUM REQUIREMENTS

The District of Columbia Office of the Chief Financial Officer, Office of Lottery and Gaming (OLG) requires a Contractor to audit its draw games, special event drawings, ticket destruction, and to monitor the Computer Control Center to ensure the Lottery games are conducted with credibility and efficiency.

# 3. <u>ESTIMATED REASONABLE PRICE AND REASONABLENESS</u> <u>DETERMINATION</u>

The estimated contract total price is \$223,435.00
