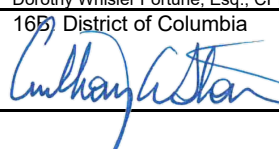

Paragraph 1 now read as follows: “Pursuant to Section I.8 – Changes, the District hereby exercises an extension for the period of January 28, 2025, through June 27, 2025. The funding for this period is not to exceed \$200,000.00. The cumulative value of the contract is increased by \$200,000.00 to an amount not to exceed \$2,879,450.99.” 2.
