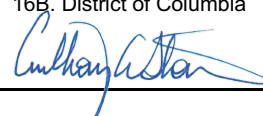

The District intends to achieve the following with Modification 11: A. Pursuant to Section I.8 – Changes, the District hereby extends the term of the subject contract for a second period of October 1, 2026, through November 30, 2026. The funding for this second period is in the not-to-exceed amount of \$58,679.26. The total value for the extension period, including Modification 10, is not-to-exceed \$234,717.01. The cumulative value of the contract has hereby increased from \$2,439,216.75 by \$58,679.26 to a not-to-exceed amount of \$2,497,896.01. B. All other terms and conditions shall remain unchanged.
