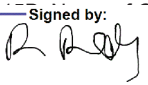

CHANGE-OF-NAME AGREEMENT

Canon Solutions America, Inc. (Contractor), a corporation duly organized and existing under the laws of the State of New York, and the Office of the Chief Financial Officer, Office of Contracts for the District of Columbia (Government), enter into this Agreement as executed by the Contracting Officer.

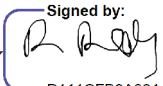
1) The parties agree to the following facts:

- a) The Government and Contractor entered into contract number CFOPD-23-C-032, effective August 10, 2023. Hereafter, the term “the Contract”, as used in this Agreement, shall mean contract number CFOPD-23-C-032 and all other contracts and purchase orders, including all modifications thereto, entered into by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed, if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts or purchase orders).
- b) Contractor, pursuant to a Certificate of Merger filed with the State of New York on December 24, 2024, merged with and into Canon U.S.A., Inc., a New York Corporation. The name of the merged entity is “Canon U.S.A., Inc.”, a New York Corporation.
- c) Effective 09/12/2025, Canon U.S.A., Inc. enstated its corporate registration with the DC Department of Licensing and Consumer Protection to reflect the new entity name.
- d) Canon U.S.A., Inc. assumes the obligations and liabilities of the Contractor under the Contract, and therefore, the rights and obligations of the Government and of the Contractor under the Contract are unaffected by the merger and name change.

2) In consideration of these facts, the parties agree that:

- a) The Contract covered by this Agreement shall be amended by substituting the name “Canon U.S.A., Inc.” in place of the Contractor name wherever it appears in the Contract.
- b) The Contract shall remain in full force and effect, subject to the terms provided therein, except as modified by this Agreement.
- c) This Agreement shall be governed by the laws of the District of Columbia.

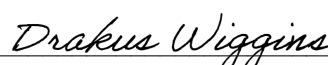
