


Pursuant to Section F.2 – Option to Extend the Term of the Contract, contained in the contract, the District hereby exercises a second fraction of Option Year 2 for the period of June 22, 2026, through September 30, 2026. The funding for this period is not to exceed \$50,000.00. The cumulative value of the contract is increased from \$684,778.00 by \$50,000.00 to an amount not to exceed \$734,778.00.</p> <p>B.
