**CHANGE-OF-NAME AGREEMENT**

GovOS, Inc. (Contractor), a corporation duly organized and existing under the laws of the State of Delaware, and the Office of the Chief Financial Officer, Office of Contracts for the District of Columbia (Government), enter into this Agreement as executed by the Contracting Officer.

- 1) The parties agree to the following facts:
  - a) The Government, represented by various Contracting Officers of the Office of Contracts, has entered into certain contracts and/or agreements with GovOS, Inc. namely:
    - i) Contract number CFOPD-25-C-009, Data Warehousing and Maintenance services
    - ii) Agreement number CFOPD-25-A-010, e-Recording services

The term “the Contracts”, as used in this Agreement, means the above contracts and/or agreements and all other contracts and purchase orders, including all modifications, made by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts and purchase orders).

- b) GovOS, Inc., by an amendment to its certificate of incorporation, dated February 24, 2026, has changed its corporate name to Neumo Tax and Licensing, LLC.
  - c) This amendment accomplishes a change of corporate name only and all rights and obligations of the Government and of the Contractor under the Contracts are unaffected by this change.
  - d) Documentary evidence of this change of corporate name has been filed with the Government.
- 2) In consideration of these facts, the parties agree that:
  - a) The Contracts and Agreements covered by this Agreement are amended by substituting the name Neumo Tax and Licensing, LLC for the name GovOS, Inc. wherever it appears in the Contracts and/or Agreements; and
