Pursuant to Section F.2 – Option to Extend, contained in the contract, the District hereby exercises Option Year 1 for the period of August 21, 2026, through August 20, 2027, for Primary Delinquent Collection Services for Debt (Scope A) and System Maintenance. The funding for this period is not to exceed \$3,982,613.93. The cumulative value of the contract is increased by \$3,982,613.93 from \$3,794,822.81 to an amount not to exceed \$7,777,436.74.
