

1) Section B.3.1.8(6) is added as follows:

6. The distinct payment milestones for Year 1, Day1 Hosting Services and Associated Technical Administration shall be applied as follows:
 - A. 60% when the following have occurred:
 1. The Contractor's Primary Data Center hosted infrastructure is built in accordance with the hosting modification to the contract and is functioning as necessary to support project implementation activities with throughput and connectivity to the District.
 2. Environments previously implemented at the District's Server Facility at 1101 4th Street SW have been successfully migrated to the Contractor's Primary Data Center, new non-production instances have been stood up at the Primary Data Center (as identified in Section C.5.3.1 of Modification No. 2), and the Primary Data Center is supporting ongoing project activities.
 - B. 20% when the Contractor's Secondary Data Center infrastructure is established and ready to be connected to the OCTO data centers and a successful failover test to demonstrate that production data is being replicated to the Secondary Data Center has been conducted ("Base Level Disaster Recovery Test").
 - C. 20% when the MITS solution is live in production and in use by OTR. This would include the satisfactory resolution of critical security control issues prior to go-live.

2) Section B.3.1.8(7) is added as follows:

7. The Contractor shall invoice the annual amounts of Hosting Services Years 2 through 5, each in four quarterly invoices, prorated respective to the annual amounts and due following the completion of each quarter (in arrears).
