
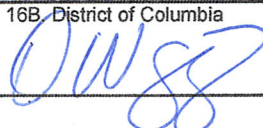

The Base Period amount is increased by \$5,850,000; for the addition of Hosting Services Years 3, 4 and 5 in the amount of \$3,350,000 and to purchase an optional integrated fund accounting system, including general ledger capabilities in accordance with Section B.3.1.7, CLIN 3 of the contract in the amount of \$2,500,000. The Base Period amount is increased from \$39,950,000 to \$45,800,000.
